- Planning –Emergency Response Plan update. Working on updates to the plan. Due in October.
 - Peggy is adding specific verbiage for Train Derailment catastrophes for the ERP per the request of NTSB and after-action review (AAR)

comments. Peggy will be working with other agencies to ensure the wording is appropriate.

- Exercise / Training -
 - Hazmat Awareness/Ops scheduled for 8/17 & 8/18 to be hosted by Winona, an instructor from Bad Day Training. So far Zero personnel have registered. The cost is \$4,700 for the training. We will be looking for a minimum of 15 attendees, or the training will be canceled. Jeremiah sent messages out to all Chiefs again to remind them of the date.
 - We may open this training up to neighboring counties if we are close to the 15 minimum attendees to fill the spots.

Conducted a TTX with Salem FD, PD and city executives, Salem Hospital, and EL Hazmat on 6/5/24. Great participation and attendance. This completes our 3rd exercise in the 4-year cycle. Looking to coordinate with Chuck McCandless from Kensington for the 2025 exercise, will finalize dates for October.

- ICS training: (There is a new requirement of a 30-day separation between the 300 & 400 trainings)
 - 300 will be October 28-30th
 - 400 will be Early April, possibly the 7-8th

This training will be hosted at FCI Elkton and will be a weekday class. Brian will be submitting these dates for approval.

 - Tier 2 reports Hazard Analysis -
 - 2 letters were sent out without hearing back from them for their reports.
 - In 2022, US EPA put out tighter rules for larger facilities. The EMA got the updates this week, so the office will be looking through these recommendations to figure out what needs to be done. We have 3 facilities that meet these requirements. Kensington facility is one of the 3. Chuck commented that he didn't see any significant changes to what is already done in their plans.
