EPA is currently on a fuel leak in East Palestine. EL Hazmat is on scene investigating and setting up to protect the creek and clean up. Follow up will be added to our records and discussed at the next meeting.

<u>Old Business</u> – Hazmat Awareness and Hazmat Operations Classes were held with approximately 11 individuals in attendance. The training went well and was hosted at East Palestine Fire Department. LEPC covered the expenses to hold this training.

Jon Yerkey from the Federal Bureau of Prison just held NIMS 300 & 400. Also working on planning a Hazmat Walkthrough training and they are in the beginning phases of this training. Anyone who is interested is welcome to attend.
